

## ONLINE ACCESS ACCOUNT LINKING AGREEMENT (BUSINESS ACCOUNTS)

Effective as of \_\_\_\_\_ (today's date), the undersigned hereby authorize the linking of all accounts of the below-named Business Entity or Entities (collectively, "Business Entities") or persons for access via online banking at any website owned, operated, controlled or maintained by OptionsHouse, LLC or any of its affiliates (collectively, "OptionsHouse") (the "Service"), without restriction. Such accounts may include, without limitation, investment and brokerage accounts (for example and without limitation, mutual funds, stocks, securities, annuities) and any and all other accounts that OptionsHouse may now or in the future hold for or on behalf of any named Business Entity or person. On my/our own behalf individually and on behalf of the Business Entity for which I/we are the authorized signers of this Agreement, I/we agree as follows: Any person authorized to access any of my/our accounts named herein or any account of any Business Entity named herein is hereby authorized to access all accounts of mine/ours named herein and all Business Entities named herein, when such access is accomplished electronically via the Service in accordance with this Agreement. Each such person shall be entitled to such access, whether or not such person is or is not named in any particular account documentation as an "Authorized Agent" or "authorized signer" or whether such person is otherwise authorized to sign on a particular account. Each such person shall further be entitled to access and control all such accounts singly via the Service, without regard to any multiple signer designations, requirements or restrictions that might otherwise be applicable to a specific account but for this Agreement. Such access includes, without limitation, the ability to electronically control such accounts, to view, initiate transactions and withdrawals, transfer money, change addresses and other account information, generally perform all types of electronic transactions to and from, each account of mine/ours and each Business Entity and to further authorize other users to access the accounts to perform similar functions (under the control of such persons authorized hereunder). I/we and each Business Entity, individually and collectively, agree to indemnify, protect, hold harmless and defend OptionsHouse from and against any and all damages, expenses, liabilities or costs (including attorney's fees and court costs), of whatever kind or nature, arising from (a) OptionsHouse's providing the Service to any of the Business Entities or persons authorized by this Agreement and (b) allowing any of the accounts to be linked to one another for access via the Service. The undersigned individuals whose Social Security Numbers appear below further authorize OptionsHouse to link all personal accounts on which the undersigned are identified by such Social Security Numbers (whether held individually or jointly with another), to all of the accounts of the persons or Business Entities shown below for online access for all purposes described in this Agreement. The undersigned understands and agrees that allowing access between personal and business accounts via a single ID and password is provided for convenience only and does not affect any prior agreements between the undersigned and OptionsHouse that may, for example, restrict the use of loan proceeds, prohibit the commingling of business and personal funds, or otherwise. It is explicitly understood that the terms of any such prior agreements shall continue to bind the parties hereto. **FURTHER RESOLVED**, that any of such Authorized Agent(s) be, and each of them hereby is, authorized to execute in the name and on behalf of this Business Entity and to deliver to OptionsHouse an Online Access Account Linking Agreement and to provide an indemnity and hold harmless to OptionsHouse in connection therewith, and any and all other supporting documentation governing the establishment of the online service (collectively, the "Agreements") with such changes, if any, as the Authorized Agent(s) executing the same shall approve, and to otherwise conduct any business whatsoever relative to the account(s), Agreements, and online service as may be necessary or advisable in order to carry out the full intent and purposes of said Agreements and of these resolutions.
